

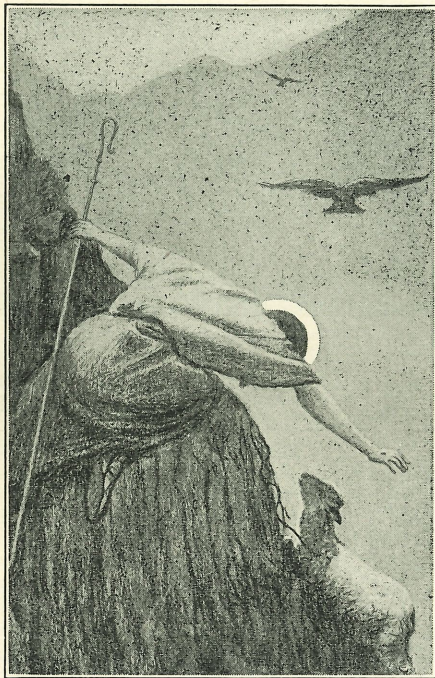

A VISIT TO OUR INSTITUTE

It was about a year after I left the Lutheran School for the Deaf as teacher when the opportunity was offered me to see the place again. My husband had been asked by the Board of Directors to preach the dedicatory sermon at the completion of the girls' dormitory. To be sure, I was real excited to see the new building and the many old friends who had grown near and dear to me during the years I had taught there.

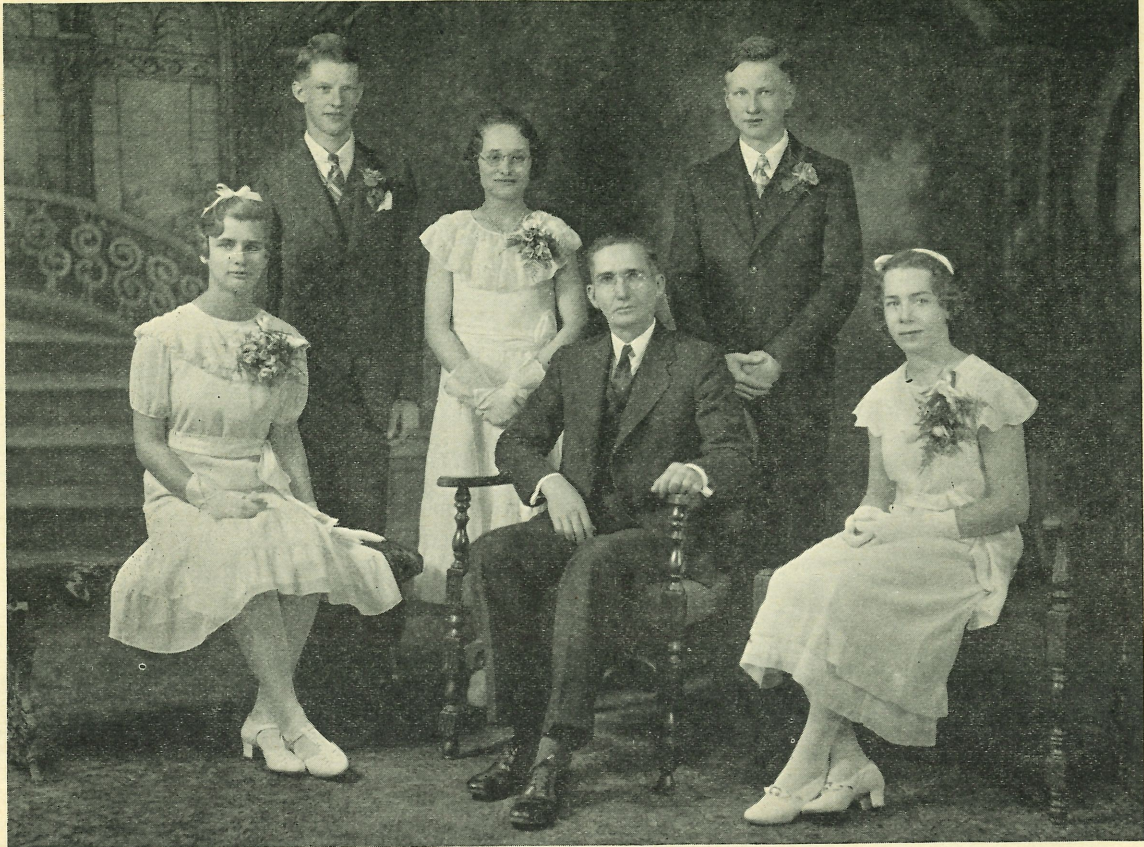
On May 9th, the Friday before Dedication Sunday, my husband and I boarded the "Greyhound" at Fond du Lac, Wisconsin, for a pleasant trip to Detroit. We arrived there at 10 o'clock in the evening and were met by Director Klein with his smiling face which assured us of a hearty welcome. After a refreshing luncheon at the Klein home and a pleasant chat, we were taken to the new dormitory and ushered into the hospital room, not as "patients" but as first guests. This room was to be our home during our stay at the school. What a bright, cheerful, convenient room, fittingly furnished! We were greeted by an intangible air of friendliness. Too eager to wait until morning to see the new dormitory we went on an inspection tour accompanied by Director Klein and the Matron, Miss Theilmann, before we retired for the night.

Every room offered a new surprise. The little girls' living room with its Kindergarten tables and chairs, appropriate pictures on the walls and colored drapes appears like a fairy house. To teach the little tots order and proper care for playthings and toys, each child has its private drawer in which its belongings are kept when not in use. Adjoining this room is the older girls' living room, attractive from floor to ceiling. The study table with comfortable chairs and fine bookcase makes it an ideal place for study. The piano, floor lamps, and davenport give it an air conducive to rest and enjoyment. How proud the girls are of this room.

We now proceeded to the second floor. The room which attracted our attention most was the smallest girls' bedroom, executed in ivory and pink. Ivory beds with pink spreads, small dressers, chairs and pretty pink ruffled window drapes. What a picture to step into this room at midnight and see seven little heads resting peacefully on their pillows. If only the parents of these children could see this picture as we saw it.

The larger girls' bedrooms look so cozy and homelike with the dark furniture and colored bedspreads to match the window drapes, each bedroom in a different color scheme. The matron's and the teachers' quarters which were shown us the next day impressed us most favorably. They were neat, cozy and homelike.

On Saturday morning we were greeted by the smiling and friendly faces of the children who were as anxious to see us as we were to see them. Each one had its own little story to tell in its own way. To my surprise one little girl of whom I did not expect it wrote on an old piece of slate and brought it to me and I read: "Rev.

and Mrs. Heschke came to school last night." This revealed the result of GOOD teaching on part of the teachers at the school.

We also devoted some time visiting the several class rooms in which we found patient and hard-working teachers. If only more hearing parents and also children would visit a class in Catechism at the Deaf School! Surely they would find reason for gratitude toward their God. It is a never-to-be-forgotten experience.

The entire Institution has an air of Christian homeliness and friendliness. This is reflected in the behavior of the children toward each other and toward their superiors. The day is begun and ended with prayer. The outstanding factor at this school is that the deaf child learns to know its Savior. Parents, there is no better place to send your deaf child.

On Tuesday we returned home, happy and thankful that we were privileged to visit the school and hoping that within a short time the boys also will be living in a new dormitory.

May the good Lord continue to bless this our school and lead many more deaf children to OUR ONLY LUTHERAN SCHOOL for the Deaf.

THE DEAF IN GERMANY

From An Article, written by Johannes Karth, formerly director of a School for the Deaf in Breslau, Germany, appearing in translation in the American Annals of the Deaf, we learn the following interesting facts: That the higher the cultural life of a nation and the more prosperous and stable its government, the more advanced is the education and social happiness of the deaf of the nation; that the number of deaf people decreases with improvement in hygiene conditions and the science of medicine; that deafness is divided into congenital and adventitious deafness in the proportion of about 1 to 5, and that any family, however protected, may have deaf children; that deaf children should be sent to a Kindergarten school earlier than hearing children; that there were 88 schools for the deaf in Germany at the beginning and 73 at the end of the World War; that the object of all schools for the deaf should be linguistic or language-giving and that in pursuance of this object the applied methods of instruction should vary according to the mental outlook of the child; that not all deaf children can be taught to speak and read the lips; that all schools for the deaf should include physical, spiritual and vocational training in their curriculums, and that the welfare of the adult deaf in after-school life should be an object of solicitude and care with a view of advancement, protection and preservation of their rights as citizens of the country in which they may live.—Silent Missionary.

SEES RED AND WE DON'T BLAME HIM

A deaf carpenter was given work. After the first day his foreman approached him with pay and this little note: "You have done good work today, but you are deaf and might get hurt." Nothing can make us see red easier than when we hear of cases such as this. Foremen should be intelligent enough to know that accidents will happen now and then, no matter whether you have two useless ears attached to the sides of your head or a dozen swell ones. If a deaf man should be turned down for a position as a buzz saw operator on the grounds that it is too dangerous, then let the foreman demonstrate how the saw can be operated blindfolded. We grow weary of these tales; we would like to kick such persons.—G. in the Oklahoman.
