
ANNIVERSARY FELICITATIONS

This house of mercy has become in our midst a strong and hardy plant. On its spacious and beautiful campus, in its modern classrooms and worship-inspiring chapel hovers an atmosphere of contentment. The actions of the happy youngsters describe "their happy home away from home." Neatness and order, down to the minutest detail carefully filed in the director's office, bespeak a wise and able management. We could continue to elaborate in this exultant strain to the point where it might seem boastful. In humble gratitude we say: "Soli Deo Gloria!" These achievements were not wrought through human wisdom. They are the result of God's bountiful blessings upon a work performed in response to His clear command. Our Institute is God's answer to the prayers of those who with their means have also generously supported it. Boards and faculties have labored earnestly in Jesus' name; congregations have stood staunchly behind our Deaf Institute project; individuals have made prodigious contributions in money and in service. Among the latter the name of one man stands out prominently today, and this brief article is an attempt to pay him a well-deserved tribute. We refer to our beloved Director John A. Klein, who has given the best years of his past to this glorious work, and who is this year observing the thirtyfifth anniversary of his service in our Institute for the Deaf. First he

the Kingdom's service as Director | Dr. John Behnken, Synod's present Klein's. Yet we have space to touch on the high-lights of his career, which will also reveal how God prepares his future leaders in advance for their stupendous tasks.

John A. Klein was born in the "Lone Star" state January 13, 1888. The name of the town was Spring. Frequently prominent men spring from the same community and have enjoyed similar advantageous environments. Thus Director Klein in his youth attended Trinity parochial school at Klein, Texas, the same

President. After his confirmation, Mr. Klein entered Concordia Teachers' College at Addison, Ill. (Now River Forest.) He was graduated from this College in 1908. His sympathy for the Deaf was then already in evidence, for immediately after graduation he accepted a call to our Lutheran Institute for the Deaf in Detroit. In the following year he took special training for teaching the Deaf at the Wisconsin State Teachers' College in Milwaukee. On the 12th Sunday after Trinity,

was installed as a teacher in our Institute. The service was held in St. Peter's Church, Detroit, the sainted Rev. H. C. F. Otte preaching the installation sermon. The latter based his sermon on the Gospel lesson for the Sunday, "The Deaf Man Healed." The speaker beautifully pointed out (in the German language) 1, "That a Teacher in our Institute is in th Service of Christ. 2, That Jesus Stands at his Side in this Calling."

Director Klein missed no opportunity which might better qualify him for his chosen calling. He took a series of special courses at the Detroit Teachers' College, now Wayne University, where he received his diploma in 1919. In 1930 he took a summer course at the Central Institute for the Deaf at St. Louis, Mo. He has received a Class "A" diploma from The Conference of Executives of American Schools for the Deaf. For a time he served on The State Advisory Committee for Special Education. He is a member of The Social Workers' Club of Detroit. The Association of American Instructors of the Deaf, and The Conference of Executives of American Schools for the Deaf.

Our beloved Director has used his wide range of gifts unselfishly in the service of God's Kingdom. Despite his extremely heavy schedule at the Institute he is president of The Iroquois Avenue Christ Lutheran Church, one of the largest congregations in the city of Detroit. In the large Sunday School of this congregation he has been Assistant Superintendent for many years. For ten years he served on the Board of Management of the Detroit Lutheran Sunday School Teachers' Institute. At present he is Deputy Superintendent of the Lutheran Schools of Michigan.

Finally, our Director Klein is also an exemplary family man. He has applied the principles of Christian education to himself and his housenora Strack of Spring, Texas. He has a son and a daughter by this marriage, First Lt. John J. Klein, Jr., now with the "Rangers" somewhere overseas, and Mrs. Ethel Fontenot of Houston, Texas.

The wife of a successful man usually deserves an equal share of credit. Director Klein cheerfully submits to this verdict. His present faithful helpmeet is the former Miss Blandina Smukal, daughter of the Rev. Robert Smukal of Detroit. They became the parents of twins, a daughter, who died in infancy, and a son, Robert, who was inducted into the armed forces shortly after his graduation from high school last June.

We should like to read the lifestory of Director Klein from his own pen. But he is a man of few words indeed, when called upon to speak about himself. We humbly thank God for the gift of such a faithful servant. The whole Church is the beneficiary of his service. In closing, we extend to Director Klein our hearty congratulations on his THIR-TY-FIFTH ANNIVERSARY. May the Lord, who has signally blessed his labors in the past, continue to do so also in the years to come, so that the living Gospel of our Savior may also dwell in the hearts of the many deaf children entrusted to his

FORMER PUPIL EN-TERS COLLEGE AT AGE OF FIFTEEN

One of our former pupils, Jerry Jordon of Roseville, Michigan, has a scholastic record which anyone, even a hearing person, could be proud of. At the age of seven Jerry was stricken with Spinal Meningitis, which left him totally deaf. His education in the grade school was discintinued and for one year he stayed at home during which time he also lost his voice.

Deeply concerned over her son's handicap and his future education, Mrs. Jordon enrolled him in our school. We well remember the first few weeks how Jerry whispered his answers to our questions and then only after much coaxing. Since he could not read lips it was impossible to carry on a conversation with him, except by the writing method. His adjustment to a life of silence was far from easy. It wasn't long, however, and Jerry was making unusually rapid progress in lipreading and the other subjects which soon brought him to the head of his class. At the age of 12 he was confirmed and received his eighth grade diploma from our

school. In the fall of the same year he entered the Roseville public high school for hearing children, where he rarely missed being on the monthly honor roll.

Last year he attended the high school in Flint, Michigan, because of vocational training which he desired. This last June at the age of fifteen he completed his high-school education in Flint and passed a difficult entrance examination for Gallaudet College, Washington, D. C. A letter recently received from him follows.

Dear Mr. Klein.

Mr. Bellhorn, all My Former Teachers, and Schoolmates:

You have probably forgotten that I've existed since you have not heard from me for 'nigh onto three months. I am in M. S. D. as you probably know and I like it here.

I have been preparing for college ever since I entered this school and, recently, I was notified that my work was very satisfactory and the college has admitted me. Not bad for a fifteen year old. Much of my success, I am sure, is due to you and Mr. Bellhorn, for it was you who taught me, who guided me and who built up my mind when it might have grown stale through my sudden deafness. It was you and the faculty who taught me to lip-read and then helped me become a very good lip-reader. I therefore wish to thank you all for the help you gave

Now let me tell you something about myself. I came here last fall and took up the subjects of Science, Literature, Civics, Math, (and later Algebra when I began to prepare for college in Oct.), and printing. I also took part in extra-curricular activities and joined the Boy Scouts, (I am now a full-fledged

Star scout with eight merit badges), the Sunday School teachers, and the Science Club. I also joined the Journalism Club and became the editor of the Michigan Mirror, which is the paper that the school publishes twice a month.

What about my classmates? Have you heard from Anna, Billy Noel, Norman, and Irene? What have they been doing? Have you still got a large family, of pupils of course?

I wanted to attend your festival today but, unfortunately, I had to take part in our graduation exercises this afternoon so ——. When I come home for summer vacation I may drop in, if I have time, and visit you again. I plan to work this summer to help pay for my college expenses.

If you answer my letter, I think you had better send it to my home since school closes Wednesday.

ANNUAL MEETING of the EV. LUTH. INSTITUTE FOR THE DEAF

The Annual Meeting of our Institute was opened with a brief service held in the chapel, the Rev. E. E. Rossow conducting the service.

The business meeting was called to order by Rev. H. R. Wacker, Acting President. He reported that the President, Mr. Fred Auch, had been granted a leave of absence to become Lieutenant Commander in the Navy Construction Battalion.

After the Minutes of the last Annual meeting held on June 10, 1942, were read and approved, the Acting President presented the Annual Report in which he reviewed the business and summary of our School's operation during the past fiscal year. The Report, as presented and accepted, was very gratifying, and it was recognized as being the best in the history of our School. The financial condition of our School was also the most gratifying in its history. The debt of \$52,488.00 was reduced by \$32,328.00, leaving a debt of \$20,200. It has indeed been a year of rich divine blessings for our Institute.

Mr. Frad Auch, and Mr. L. C. Knorr were reelected as members of the Board of Directors, and the Rev. L. G. Heinecke was elected in the place of the Rev. E. T. Bernthal, who for valid reasons, declined to be a candidate for re-election. A rising vote of thanks and appreciation was extended to Pastor Bernthal for valued services rendered and his wise counsel and continued interest in the work of our Institute.

The School Board's report was read by the president of the board, the Rev. Geo. M. Krach. The activities of the Board, school enrollment,

and general circumstances of the school were presented and accepted.

Mr. Louis Knorr, Financial Secretary, presented a printed Profit and Loss Report which had been prepared by Mr. Kaufman, a member of the Auditing Committee. The Auditing Committee reported that the books were examined and found correct.

After completing resolutions for the coming year and extending thanks to the various organizations which contributed so liberally of their services and supplies, the meeting was adjourned with the singing of a hymn and with the Lord's Prayer.

ANNOUNCING SEVENTY-FIRST SCHOOL YEAR

The new school year of our instiute will begin on Wednesday, September 8th. All out of town children should arrive on that day or earlier if that is more convenient. If the pupils come by train or bus, the parents should so notify us in order that we may meet their children at the stations. Detroit pupils and such as come by auto may come one day later or September 9th.

The school management expects all children to bring the required amount of clothing and that each garment be marked with the child's full name.

OUR ANNUAL FESTIVAL

The Institute celebrated its annual festival on Pentecost Sunday afternoon June 13th. The weather was ideal, the picnic grove was well filled with friends of the Institute from far and near, and the collections for the day were the best in the history of the school. The Rev. A. H. A. Lober of Messiah Lutheran Church, Detroit, delivered the main address,
